LCA & sustainability certificate

Introduction

Northcone's lighting poles are unique with their low material consumption and long, durable service life.

To support this, as well as measure the company's overall footprint on the environment, the accredited Environmental Investigation Company Miljögiraffen has conducted a comprehensive study and LCA analysis. The study conducted according to LCA ISO 14040 looks at the entire flow from raw material (magnelis in the post, foundation and

wedge ring), to our manufacturing, transportation, installation use and finally reuse. For each step, the footprint and environmental impact are calculated.

The study shows that Northcone's lighting poles are significantly more environmentally friendly than other alternatives on the market. A short summary is shown below. For a complete analysis, see "Environmental report" at www.northcone.se

Minimal leaching from the post itself

The leaching of zinc to nature is almost non-existent. The extremely low leaching of materials contributes to the immediate environment of the pillar not being affected by heavy metals. Sensitive ecosystems, species worthy of protection and wet environments can be found near roads and their drainage systems.

Low environmental impact from the factory

The factory in Borlänge only uses electricity from eco-labeled hydropower or wind power. Manufacturing also does not use any wet varnish, which is a process that otherwise requires solvents. The lacquered alternatives are offered via powder lacquer or thermal lacquer. These two methods are more environmentally friendly as they take place in closed systems without solvents.

Recycling

When the post has finally reached the end of its service life, all material is recyclable, and a new one can be made from an old post. The low weight of the post also provides environmental benefits for transport to and from the factory.

Total impact

If you look at the total environmental impact according to the methods ReCiPe (total impact), IPCC GWP 100 (climate impact) and USEtox (toxins), the study shows that Northcone's lighting poles in total have as much as 10 -50% lower environmental impact compared to traditional poles.
